THE 4th BAKU INTERNATIONAL BOOK FAIR

Participation Terms

1. General Provisions

The 4th Baku International Book Fair will be held on 18-19 September 2015.

The official opening of the Fair is on 18 September 2015, at 11:00. The exhibition is open every day from 10:00 a.m. till 18:00 p.m.

The organizer of the 4th Baku International Book Fair is the Ministry of Culture and Tourism of the Republic of Azerbaijan.

2. Participants

National and international publishing houses, book distributors and sellers, polygraph institutions, copyright agencies and all the institutions engaged in book publishing and distributing can take part in the Fair.

3. Exhibits

Different books, magazines, notes, cards, stamps, plates, CDs, audio and video recordings, slides, geographical maps, atlases, globes, modern publishing techniques and equipments in copyright can be demonstrated. Participants are entitled to sell or distribute the books for free.

4. Registration in the fair

Those who want to participate are considered to be registered after sending an application and by agreeing to the participation terms.

5. Fair space, means and services

The fair stands and equipments will be provided for free.

The participant may use the exhibition space only for the purposes of the Fair. During the exhibition the participant should not cause obstacle to the other participants and stands.

The succession of the stands will be according to the application receipt date. It is at the discretion of the Organizing Committee to decide on the placement of the stands.

The participants must be at their stands during the fair.

Dismantling is allowed only when the fair is over and must be finished in a day period.

The Organizing Committee does not take any responsibility for damage or harm done to the books through carelessness of participants during work-hours of the fair.

6. Catalogue

The Organizing Committee will publish a catalogue according to the accepted applications on the occasion of the opening of the fair. Information about the participants will be published for free in the catalogue. Participants should provide the organizers with brief information (250-300 signs) about their publications in order to publish them in the catalogue. The Organizing Committee is not liable for incorrect information provided by the participants. The Organizing Committee will present one copy of the catalogue to each participant for free. The participants should pay for each additional copy of the catalogue. The participants can take the catalogue and programme at the place where the Fair will be held.

7. Force-majeure cases


The Organizing Committee does not take responsibility for the interruption of the fair in the cases of force-majeure. The Organizing Committee is entitled to change the location and work hour of the fair in such cases. The participant admits in his turn that in such cases the Organizing Committee is victims as well and is not able to pay for damage. Simultaneously the participant admits that this document reflects the full understanding between the sides and it will not be changed afterwards.

8. Accommodation

The Organizing Committee will provide assistance for hotel booking for the participants. The hotel reservations are made before arriving and paid in cash or by bank transfer by participants. The reservations are to be made after the application is received by 1 September 2015.

9. Controversial Issues

Parties expected to form "Controversial Act" in the case of controversy. In the case of possible remarks the act is the only document to be referred.
